ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 11.06.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 15.05.2012 of CPIO, EIA – Delhi in relation to information sought by him vide his application dated 16.04.2012.

Vide his application-dated 16.04.2012, Shri Praveen Sakhuja had asked for four (04) information regarding alleged visit of one ex – AD to office on 13.04.2012, namely (i) period of his stay – time in & time out; (ii) copy of relevant page of the visitors register; (iii) recording of the camera from 1200 hours to 1530 hours and (iv) if recording is not on record, the related reasons. In response, the CPIO had informed Shri Sakhuja “No record” for the first three information and “No such information exists” for the fourth information. Shri Sakhuja has filed present appeal claiming that installed cameras must have captured the visit of the ex-AD.

In view of the fresh statement tendered by Shri Sakhuja, CPIO, EIA – Delhi is hereby directed to revisit the application dated 16.04.2012 of Shri Sakhuja, enquire into the matter once more and provide the information to Shri Sakhuja within 2 weeks of this order.
