ORDER


Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.

Shri Praveen Sakhuja vide his letter-dated 05.03.2012 had requested the CPIO, EIA – Delhi for (i) copy of office order issued by EIC for posting Shri A. C. Dutta to EIA – Delhi, (ii) copy of letter issued by EIC conveying approval of EL and permission to leave HQ from 17.02.2012 to 04.03.2012, (iii) copy of attendance sheet of Shri Dutta for 17.02.2012 and (iv) office orders issued by EIC making alternate arrangements for Shri Dutta.

The CPIO, EIA – Delhi in reply had furnished the information at (i) above to Shri Sakhuja, while informing him that information at (ii) to (iv) above has no relationship to any public activity and hence denied under section 8(1)(j) of the RTI Act. Not satisfied with the answer, the applicant has filed 2nd appeal dated 21.06.2011, demanding that CPIO should furnish the information.

Now in compliance to CIC order (case no. CIC/SS/A/2012/002980), I have gone through the case papers and observe that the CPIO has not furnished the information relating to (ii) to (iv) above.

Accordingly, the CPIO, EIC is hereby directed to re-visit application dated 05.03.2012 of Shri Sakhuja and provide him information listed at 2 to 4 in his application within two weeks of receipt of this order.
