ORDER


Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005.

Vide his letter-dated 26.06.2012, Shri Praveen Sakhuja had requested for two information related to attendance being adopted by sub offices of EIA – Delhi since January 2012, besides seeking copies of the record of attendance. In response, the CPIO, EIA – Delhi had furnished the information vide his letters dated 24.07.2012 and 07.08.2013, charging Rs. 34/- for the copies of documents sought.

Not satisfied with the above, Shri Sakhuja preferred an appeal dated 24.10.2012, alleging that he was cheated by providing copies of fabricated attendance sheets and that the amount of Rs. 34/- be refunded to him.

Now in compliance to CIC order (case no. CIC/SS/A/2012/003685), I have gone through the case papers and observe (i) that Shri Sakhuja is habitual of filing applications in a large number on almost any matter including administrative / service matters and (ii) that the required information was furnished to Shri Sakhuja by CPIO, EIC vide his letter dated 24.07.2012.

As there is no denial of information, I find no reason to interfere with the order of CPIO, EIA – Delhi and the appeal made by Shri Praveen Sakhuja stands disposed off. In case Shri Sakhuja is convinced that fabricated attendance sheets were provided to him, he may lodge a complaint with EIA – Delhi for necessary action.
