#### ORDER


**Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.**

Shri Praveen Sakhuja vide his letter-dated 20.12.2011 had sought from the CPIO, EIC (i) details of members of Group A & B of EIC / EIAs who are required to submit return of immovable property for the year 2010 and are required to be placed in public domain as per OM issued by DoPT and (ii) dates of submission of details as per the OM and others who defaulted.

In turn, vide his letters dated 20.01.2012, CPIO – EIC had informed Shri Sakhuja (i) that all group A & B officers are required to submit their return of their property & that the second part of his question (OM of DoPT) was vague and (ii) that the second question was not applicable in view of second part of first question. Shri Sakhuja has thereafter filed second appeal alleging that the information to the second part of the question and the second question was withheld deliberately.

Now in compliance to CIC order (case no. CIC/SS/A/2012/002238), I have gone through the case papers and observe (i) that “OM issued by DoPT” is vague and (ii) that an applicant needs to properly identify the information to enable the CPIO to supply it.

As the available information was furnished, the appeal filed by Shri Sakhuja stands disposed of. Shri Sakhuja is also advised to be precise while seeking information and not to misuse his right to information as a tool for harassment of the department.
