ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 21.06.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 20.03.2012 of CPIO, EIC in relation to information sought by him in his application dated 21.02.2012.

Shri Sakhuja vide his letter-dated 21.02.2012 addressed to CPIO, MoC&I had sought copies of (i) minutes of the selection committee for selection of Additional Director in EIC in the year 2009 – 2010 and (ii) copy of constituted committee who declared Shri Rajeev Raizada as a candidate suitable for the post of Additional Director. He had also requested for inspection of file noting related to above. After the transfer of application to EIC, Shri Sakhuja was informed that the information cannot be disclosed in terms of section 8(1)(j) of RTI.

Shri Sakhuja has filed present appeal demanding that the information may be furnished to him. I have gone through the appeal made by Shri Sakhuja and observe that the DPC minutes are fiduciary in nature and cannot be disclosed. At the same time, certain complaints were filed alleging irregularity in the promotion of Additional Director. As the final outcome is not known, this will also invite application of section 8(1)(h) of RTI.

As there is no denial of information on the part of the CPIO, the appeal filed by Shri Sakhuja, therefore stands disposed of.
