ORDER

Subject: Appeal made by Shri Praveen Sakhujia under Section 19 (1) of the Right to Information Act, 2005


Shri Praveen Sakhujia vide his letter dated 18.02.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 06.02.2013 of CPIO, EIC in relation to information sought by him in his application dated 07.01.2013.

The information sought by Shri Sakhujia vide his letter-dated 07.01.2013 addressed to CPIO, EIA - Delhi and the reply furnished by CPIO, EIC after its transfer to EIC, were as under:

	Information sought by Shri Sakhujia	Information given by CPIO
1.	Copy of application filed by Shri Rajeev Raizada, Additional Director for either taking loan, creating a liability, borrowing in last four years.	As per records, Shri Rajiv Raizada has not filed any application for taking loan for the specified period.
2.	Purpose for which loan / liability is being created with date of application	Not applicable in view of 1 above.
3.	Final disposal of application, and related five queries.	Not applicable in view of 1 above.

Shri Sakhujia has filed present appeal enclosing a copy of "Vehicle Particulars" of Transport Department of Delhi Government indicating hypothecation in favour of The State Bank of India of a vehicle with Shri Rajiv, alleging that the information was denied deliberately. I have gone through the appeal made by Shri Sakhujia and find that the information (regarding application for loan) available on record was furnished to him and that his allegation is baseless.

As there is no denial of information on the part of the CPIO, the appeal filed by Shri Sakhujia therefore stands disposed of.
