ORDER

Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.

Shri Praveen Sakhuja vide his letter-dated 26.03.2012 had requested the CPIO, EIA – Delhi for inspection of file noting in respect of certain order said to have been issued on 16.03.2012 and again on 23.03.2012 in respect of some nomination of Shri Sakhuja. In reply, CPIO, EIA – Delhi had informed Shri Sakhuja that the information sought had no relationship to any public activity and hence denied under Section 8(1)(j) of the RTI Act. Not satisfied with the answer, the applicant has filed 2nd appeal dated 24.10.2012, demanding that CPIO should allow inspection of file noting.

Now in compliance to CIC order (case no. CIC/SS/A/2012/003693), I have gone through the case papers and observe that though the information sought is vague, the CPIO has been able to identify it. Accordingly, the CPIO, EIA – Delhi is hereby directed to re-visit application dated 26.03.2012 of Shri Sakhuja and make arrangements for inspection of related file noting, in case the same can be identified and located, within two weeks of receipt of this order.
