ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 18.02.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 08.02.2013 of CPIO, EIC in relation to information sought by him vide his application dated 14.01.2013.

Vide his application dated 14.01.2013 addressed to CPIO, EIA - Delhi, Shri Sakhuja had sought four information in respect of OM dated 28.09.2010 of the CVC. His application was transferred to the CPIO, EIC who, vide his letter-dated 07.01.2013, had informed Shri Sakhuja that there was no such OM from CVC. Shri Sakhuja has filed present appeal enclosing a copy of CVC OM referred to by him in his application.
