ORDER


Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 18.02.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 05.02.2013 of CPIO, EIC in relation to information sought by him vide his application dated 07.01.2013.

Vide his application-dated 07.01.2013 filed with EIA-Delhi; Shri Praveen Sakhuja had requested for extract of Rule 3(ii) and 3(iii) of the Central Civil Services (Conduct) Rules 1964. This application was transferred to CPIO, EIC who vide his letter dated 05.02.2013 informed Shri Sakhuja that EIC is not the custodian of the Central Civil Services (Conduct) Rules 1964 and he may obtain the information from the Department of Personnel & Training. Shri Sakhuja has preferred present appeal under the plea that in case the EIC was not the custodian, as required under Section 6(3) of the RTI Act, the application should have been forwarded to the appropriate public authority and as such, the CPIO, EIC has failed to adhere to the provisions of the RTI Act. He should, therefore be directed to provide the requisite information to him.

I have gone through the appeal filed by Shri Sakhuja and observe (i) that an RTI application is required to be transferred to the concerned public authority (sub-section 3 of section 6 of the RTI Act) only in the cases where information seeker is unaware of where the information is held, (ii) that Shri Sakhuja has been filing RTI application with EIA-Delhi and Ministry of Commerce for information held by EIC and (iii) that Shri Sakhuja is well aware of where to seek the information from, as is evident from the various RTI applications filed by him in past.

As there is no infirmity in the order passed by the CPIO, the appeal filed by Shri Praveen Sakhuja stands disposed of.
