### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 18.02.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 08.02.2013 of CPIO, EIC in relation to information sought by him vide his application dated 14.01.2013.

Vide his application-dated 14.01.2013 filed with EIA-Delhi, Shri Praveen Sakhuja had sought details of court cases where Shri L. R. Khatana, Advocate had represented EIC/EIAs, as per a format prescribed by him. The application was transferred to CPIO, EIC who vide his letter dated 08.02.2013 had informed Shri Sakhuja that searching of records for 12 years for providing the information asked by him would disproportionately divert the resources of the organisation in terms of section 7(9) of the RTI Act.

I have gone through the appeal filed by Shri Sakhuja and the case papers and observe (i) that Shri Sakhuja is habitual of filing applications in a large number on almost any matter and (iii) that for an organisation operating with less than 50% of the sanctioned strength, I have no reasons to disagree with the contention of CPIO, EIC that searching for entire records of all employees would result in diversion of its meagre resources. Accordingly, the appeal filed by Shri Sakhuja stands disposed of. Shri Sakhuja is also advised to be precise while seeking information and not to misuse his right to information as a tool for harassment of the department.
