## ORDER

Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.

Shri B. C. Saxena vide his letter dated 07.03.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 29.02.2012 of CPIO, EIC for not providing information requested by him vide his application dated 27.01.2012.

Vide his letter-dated 27.01.2012, Shri Saxena had sought certain information relating to Central Civil services (Recognition of service associations) Rule 1993 as GS (General Secretary) of 'Delhi Region Export Inspection Employees' Association'. The letterhead also claimed that the said association was recognised by the Export Inspection Council.

Whereas there can be no objection to any citizen seeking information as per law, however, if someone under the garb of seeking information tries to perpetuate an illegality viz pseudo status of oneself or of the organization he perpetrates to represent, the same is not permissible under the law as law neither permits nor admits of any mischief sought to be played by any one with ulterior motive of staking his claim on that basis later on. Shri B. C. Saxena has not sought the information in a straight forward manner as a citizen, as per law and is rather seeking information under a pseudonym, which is not permissible under the law (RTI Act) and is also likely to be taken undue advantage of to perpetuate the wrong, however, as the CPIO has furnished the information to him vide his letter dated 29.02.2012, the appeal needs to be dealt on merit.

The information sought by Shri Saxena vide his letter-dated 27.01.2012 and the reply furnished by CPIO, EIC were as under:

I have gone through the appeal of Shri Saxena and observe that information at a & d did not belong to EIC, information sought at b could in fact be more than 20 years old and rest of the information, as available on records has been provided by the CPIO.

Since the information requested has not been denied, I do not find any reason to issue any further instructions to CPIO, EIC and the appeal made by Shri B. C. Saxena stands disposed of. Shri Saxena is also advised to seek information in a straightforward manner as a citizen, without any pseudonym, as per the provisions of RTI Act.
