ORDER


Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 02.01.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application bearing reference EIC-13-84.

Information sought by Shri Sakhuja was supplied by the CPIO vide letters dated 25.11.2013 & 16.12.2013. Thereafter, in response to letter dated 02.01.2014 of Shri Sakhuja that claimed that the information was not complete, the CPIO, EIC had transferred the RTI application to the five EIAs for supplying the information to Shri Sakhuja. As per the records available with CPIO, EIA – Delhi, Kolkata & Mumbai have since furnished the information to the applicant vide their letters dated 21.01.2014, 25.02.2014 and 20.02.2014 respectively.

Under the circumstances, the CPIO, EIA – Chennai & CPIO, EIA – Kochi are hereby directed to provide the requested information to Shri Sakhuja within 7 days of receipt of this order. At the same time, CPIO, EIC is hereby directed to allow inspection of relevant records to Shri Sakhuja, if he so desires, within 15 days of receipt of this order.

With the above directions, the appeal filed by Shri Sakhuja stands disposed of.
