### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 25.02.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 02.01.2014.

Vide his application-dated 02.01.2014 (EIC-14-002); Shri Sakhuja had sought information regarding the basis on which he was asked to deposit fee of Rs. 3450/- for providing information sought by him earlier. The required information was furnished by the CPIO vide his letter dated 20.01.2014. The present appeal has been filed by Shri Sakhuja seeking refund of the fee earlier paid by him.

I have gone through the appeal and observe that section 19(1) of the RTI Act can be invoked only if the information is not furnished by the CPIO.

As the information sought for has been supplied by the CPIO, the appeal filed by Shri Sakhuja stands disposed of.
