ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja has filed an appeal, dated 25.02.2014, under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 02.01.2014.

Information sought by Shri Sakhuja vide his application dated 02.01.2014 bearing reference EIC-14-005 and supplied by CPIO, EIC vide his letter dated 06.01.2014 was as under.



The present appeal has been filed by Shri Sakhuja as he is not satisfied with the information furnished at 1d, 1e, 2, 4, 5 and 6 above. According to Shri Sakhuja, whereas information at 1d & 1e has been mixed up, no information has been provided for 2, 4, 5 and 6 above.

Under the circumstances, the CPIO, EIC is hereby directed to revisit 1d & 1e of application dated 02.01.2014 (bearing reference EIC-14-005) and provide the requested information to Shri Sakhuja within 7 days of receipt of this order. At the same time, the office of Director EIC is directed to provide information related to point 2, 4, 5 & 6 of the application to Shri Sakhuja within 15 days of receipt of this order.

With the above direction, the appeal filed by Shri Sakhuja stands disposed of.
