ORDER

Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.

Shri Parveen Kumar vide his letter dated 01.03.2014 (received on 07.03.2014) has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 20.01.2014 of CPIO, EIC in relation to information sought by him vide his application dated 24.12.2013.

Information sought by Shri Kumar vide his application-dated 24.12.2013 (concerning selection of Joint Director (T) in EIC, interview for which was held on 29.10.2013) addressed to the CPIO, DOC and supplied by CPIO, EIC upon its transfer was as under.

1.	Name & details of selection committee	The process of recruitment is still in progress as such the information couldn't be provided. However, in the interest of transparency it is informed that the committee consisting of Chairman of the Amve. Committee, 2 Members of the Council, Director and One member appointed by the Central Govt. was constituted as per the Recruitment Rules.
2.	Recommendations details of each & every candidate (including the applicant). Every details which include individual & compilation of joint recommendation by the selection committee or as procedure followed by the selection committee member.	Information related to other candidates who are not selected cannot be disclosed to a third party.
3.	Name of the candidates selected & empanelled.	1) Shri Balachandra Nadig and 2) Jali Surendar Reddy.
4.	The certified copy of the Bio-data & fact sheet of candidates selected & empanelled.	Information could't be disclosed as the recruitment is still in progress. However, in the interest of transparency the educational qualification of the selected candidates are provided herewith. a) Shri Balachandra Nadig: MSc., MS. b) Shri Jali Surendar Reddy: MVSc., MBA (IIM-A)

The present appeal has been filed by Shri Kumar as he considers that the information was not supplied by the CPIO deliberately. The RTI Cell had sought the related records / views from the concerned CPIO vide its letter dated 10.03.2014. Whereas the views were furnished vide letter dated 11.03.2014, the records have not yet been produced in spite of e-mail reminders dated 19.03.2014 & 26.03.2014.

I have gone through the appeal and observe that

- Information at Sl. 1 has been furnished,
- Information at Sl. 2, 3 & 4 has been furnished partially, and
- Information at Sl. 5 has not been furnished.

I do not agree with the contention of the CPIO that the process of recruitment is still not over. Under the circumstance, Shri Kannan Kasturi NS, DD (NT) & CPIO is hereby directed to provide the following information to Shri Kumar free of cost, within two weeks of receipt of this order.

- a. Copy of the minutes of selection committee meeting, with details of the members duly concealed; and
- b. Copy of bio data & fact sheet in respect of (i) candidates recommended for selection, (ii) candidates empanelled under wait list, if any and (iii) the applicant.

With the above directions, the appeal filed by Shri Parveen Kumar stands disposed of.
