### ORDER

**Subject: Appeal made by Shri Bhagwan Chand Saxena under Section 19(1) of the Right to Information Act 2005**

#### **Facts of the Case:**

Shri B C Saxena vide his letter dated 15 Feb 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 27 Nov 2013.

Vide his RTI request dated 27 Nov 2013 Shri B C Saxena had sought information on two points in relation to his representation to Shri M Prasad, Chairman EIC submitted . The information sought reads as:

- 1 Status of the letter in terms of action taken in the letter submitted by Shri B C Saxena dated 6 May 2013.
- 2 File movement from date of delivery in the office of Chairman.

CPIO MOC&I vide their letter dated 2 Jan 2014 replied to Shri Saxena stating that information was not with their section and therefore CPIO MoC&I forwarded the request to EIC Delhi for providing the information.

CPIO EIC Delhi vide his letter dated 20 Jan 2014 stated that the information is not held by him and therefore no inputs could be given.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 15 Feb 2014.

CPIO MoC&I vide their letter bearing no 2/9/2013-Export Inspection dated 26 March 2014 forwarded the appeal to FAA EIC Delhi for disposal and hence this appeal is being addressed from this office

The issues raised in the appeal of the applicant are there is an intentional denial on providing the information sought by CPIO and therefore CPIO be directed to provide the information.

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that the applicant be provided with the information which exists as per provisions of Section 2 of RTI Act 2005. In the case instant the applicant had submitted a representation to office of Chairman EIC and he is seeking the complete details of the movement of representation.

Neither the CPIO MoC&I nor CPIO EIC Delhi have been able to trace out any reference of the representation submitted by the applicant and hence they have denied providing inputs.

**Orders:**

I find no reason to give no further directions to CPIO as there is no denial of the information to the applicant.

This disposes off the appeal of Shri B C Saxena.
