### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 31 March 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 14 Feb 2014 (EIC-14-012).

Vide his RTI request dated 14 Feb 2014 Shri Praveen Sakhuja had sought information on the details of work allocation of officers at EIC and amendments thereof. The information sought reads as:

1. Kindly provide certified copy of the work allocation of the officers of Export Inspection Council.
2. Kindly provide certified copy of the amendments carried out in the work allocation of officers of EIC from 1 Oct 2010 until date.

RTI Cell EIC vide their letter dated 14 Feb 2014 transferred the RTI application to Shri Kannan Kasturi NS citing section 6(3) of the RTI Act 2005. The deemed CPIO EIC vide her letter dated 17 Feb 2014 replied to Shri Sakhuja stating that the information sought is neither held by him and nor is maintained by him and RTI Cell should take up the matter with appropriate section.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 31 March 2014.

The issues raised in the appeal of the applicant are that it is deliberate on part of RTI Cell and deemed CPIO EIC are shutting the RTI application and are not providing the same to the applicant. The applicant prays that he be provided the information free of cost since there is an inordinate delay in providing information.

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that

the information sought by the applicant is available on the website of EIC (public domain). Despite the fact the information should have been provided within stipulated time period.

**Orders:**

Deemed CPIO, Shri Kannan Kasturi NS is hereby directed to provide the copies of the work allocation orders of officers at EIC along with amendments, if any, within 15 days of this order

This disposes off the appeal of Shri Praveen Sakhuja.
