
ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja has filed an appeal, dated 12.02.2014 under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 25.11.2013.

Vide his application dated 25.11.2013 bearing reference EIC-13-133 (copy enclosed); Shri Sakhuja had sought six information relating to staff grievances concerning ACP / MACP. On enquiry, it has been informed by the RTI Cell that the said RTI application was transferred to Shri Rajvinder Singh, DD (NT) & CPIO in respect of information related to EIC and to Shri Kannan Kasturi NS, DD (NT) & CPIO, EIC in respect of information related to EIAs vide letters dated 29.11.2013. The RTI Cell has also informed that two communications in respect of the present appeal were forwarded to Shri Kasturi on 18.02.2014 and 07.03.2014. Whereas Shri Rajvinder Singh supplied the information vide his letter dated 05.12.2013, Shri Kasturi vide his letter dated 10.03.2014 (received by the RTI Cell on 14.03.2014) has claimed that RTI application dated 25.11.2013 bearing reference EIC-13-133 was not received by him.

Under the circumstance, Shri Kannan Kasturi NS, DD (NT) & CPIO, EIC is hereby directed to process application dated 25.11.2013 (EIC-13-133) of Shri Sakhuja and furnish the required information to him within two weeks of receipt of this order. With the above direction, the appeal filed by Shri Sakhuja stands disposed of.
