ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005


Shri Praveen Sakhuja vide his letter dated 12.02.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 25.11.2013..

Vide his application dated 25.11.2013 bearing reference EIC-13-135, Shri Sakhuja had sought five information concerning Shri Parmod Siwach. The application of Shri Sakhuja was forwarded to two CPIOs dealing with different aspects of the information sought. Information sought by Shri Sakhuja at point no. 2 & 3 and supplied by the CPIO vide letter dated 02.12.2013 was as under.

Sl.	Information Sought	Reply of CPIO
2.	Place of working of Parmod Siwach from 07 August 2011 to 15 August 2011, kindly provide certified copy of the attendance record of his for the period.	Shri Siwach was on the nominal roll of EIA Delhi since the date of his joining and therefore the place of working was EIA Delhi. However it is stated that there were some instructions from EIC as these officers were on training and formally were declared to have been posted in EIA Delhi after completion of training.
3.	Details [amount under each head] of salary / emoluments paid to Parmod Siwach for the period 01 August 2011 to 31 August 2011.	Shri Siwach drew normal salary in the basic pay of Rs. 15600/- plus a grade pay of Rs. 5400/- for the month of Aug 2011. Usual allowances as admissible were also paid to Shri Siwach.

The present appeal has been filed by Shri Sakhuja as he considers that the CPIO has not furnished copy of attendance record in respect of 2 above and details of salary under each head in respect of 3 above.

I have gone through the appeal and observe that information readily available has been provided to the applicant. As there is no denial of information, the appeal filed by Shri Sakhuja stands disposed of.
