
Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 12.02.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 25.11.2013..

Vide his application dated 25.11.2013 bearing reference EIC-13-135, Shri Sakhuja had sought five information concerning Shri Parmod Siwach. The application of Shri Sakhuja was forwarded to two CPIOs dealing with different aspects of the information sought. In respect of information at point no. 1, 4 & 5, vide his letter dated 28.01.2014, CPIO, EIC informed Shri Sakhuja that the information was neither held by him nor was he the custodians of the information sought and that the RTI Cell of EIC may like to take appropriate action to provide the same to Shri Sakhuja.

I have gone through the appeal and observe that training was organised by EIC. Under the circumstances, the CPIO, EIC is hereby directed to revisit application dated 25.11.2013 of Shri Sakhuja and provide him the information relating to point no. 1, 4 & 5 within two weeks of receipt of this order.

With the above directions, the appeal filed by Shri Sakhuja stands disposed of.
