
Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 12.02.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 27.11.2013.

Vide his application-dated 27.11.2013 (EIC-13-144); Shri Sakhuja had sought information regarding one advertisement relating to TBT response system. In reply, the CPIO vide letter dated 11.12.2014 had informed Shri Sakhuja that the information sought was vague. The present appeal has been filed by Shri Sakhuja as he considers that the CPIO has deliberately not furnished the information to him.

I have gone through the appeal filed by Shri Sakhuja and observe (i) that Shri Sakhuja files applications in a large number on any matter, (ii) no organisation can disproportionately divert its resources in searching information and (iii) that Shri Sakhuja has been advised number of times to be precise while seeking information under the RTI Act.

Accordingly, the appeal filed by Shri Sakhuja stands disposed of.
