ORDER


Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja has filed an appeal, dated 12.02.2014, under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 09.12.2013.

Vide his application dated 09.12.2013 bearing reference EIC-13-155; Shri Sakhuja had sought four information relating to foreign visits undertaken by the Additional Director. Whereas information was furnished to Shri Sakhuja in respect of point 1 & 4 vide letter dated 12.12.2013, his application was transferred to another CPIO for providing information sought at point 2 & 3.

The present appeal has been filed by Shri Sakhuja as he has not received information relating to point 2 & 3 of his application. The appeal has been filed by Shri Sakhuja after expiry of the period of 30 days, however, as the information sought concerns the Additional Director who also happens to be the Appellate Authority, the concerned CPIO, EIC is hereby directed to visit point 2 & 3 of application dated 02.01.2014 (bearing reference EIC-13-155) and provide the requested information to Shri Sakhuja free of cost within 7 days of receipt of this order.

With the above direction, the appeal filed by Shri Sakhuja stands disposed of.
