ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Shri Praveen Sakhuja vide his letter dated 31 March 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 10 March 2014 (EIC-14-019).

Vide his RTI request dated 10 March 2014 Shri Praveen Sakhuja had sought information on the details of manpower at EIC on various dates detailing sanctioned strength; men in position, details of borrowed employees from EIA; Details of manpower posted at EI section of DoC; persons outsources and hired from security agency.

In response, the deemed CPIO- EIC have responded vide their letter dated 14 March 2014 and 19 March 2014 with the applicant being provided with the information available with them on records. Deemed CPIO EIA Delhi offered inspection of records to the applicant vide his letter dated 14 March 2014.

Since the applicant has been provided with the information on records and has been offered inspection of the records as well, I find no infirmity in the actions of CPIOs and find the appeal of Shri Sakhuja bereft of merit and is disposed off accordingly
