ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 12.02.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 09.12.2013.

Information sought by Shri Sakhuja vide his application dated 09.12.2013 bearing reference EIC-13-156, and supplied by CPIO, EIC vide letters dated 20.12.2013 & 21.01.2014 was as under.

| 6. | Present work allocation of Madaan in EIC form date of his joining in EIC stating name and designation of the officer to whom he reports. | Nil. |

The present appeal has been filed by Shri Sakhuja as he considers that complete information has not been supplied to him. Whereas in respect of point 1 to 5 of his application, Shri Sakhuja is now requesting copies of related orders for work allocation, in respect of point 6, he has pointed out that the information furnished is at variance with the information available on the website of EIC.


The RTI Cell had sought the related records / views from the concerned CPIOs vide its letter dated 18.02.2014. Whereas one of the CPIOs had furnished his views vide letter dated

11.03.2014, the records / views of the other CPIO have not yet been produced / received in spite reminder dated 11.03.2014.

I have gone through the appeal and observe that demand of the applicant for copies of orders related to work allocation was not a part of the application dated 09.12.2013 and therefore not tenable. At the same time, keeping in view the variance in information available on website, Shri Kannan Kasturi NS, DD (NT) & CPIO is hereby directed to revisit point number 6 of application dated 09.12.2013 bearing reference EIC-13-156 and provide Shri Sakhuja a categorical response within two weeks of receipt of this order.

With the above directions, the appeal filed by Shri Sakhuja stands disposed of.
