ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 12.02.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 18.11.2013.

Vide his application dated 18.11.2013 bearing reference EIC-13-102 submitted to EIA - Delhi, Shri Sakhuja had sought information concerning one IWSU report, copy of which was earlier furnished by the CPIO to the applicant. The present appeal has been filed by Shri Sakhuja as he was not satisfied with the information furnished by the CPIO vide his letter dated 25.11.2013 relating to point number 1, 2, 4 & 5 of his application. The RTI Cell had sought the related records / views from the concerned CPIO vide its letter dated 19.02.2014 and reminder dated 07.03.2014. Whereas the views were furnished vide letter dated 10.03.2014 (received on 14.03.2014), the records have not yet been produced in spite of e-mail reminders dated 19.03.2014 & 26.03.2014.

Under the circumstance, Shri Kannan Kasturi NS, DD (NT) & CPIO is hereby directed to allow inspection of related records to Shri Sakhuja within two weeks of receipt of this order.

With the above directions, the appeal filed by Shri Sakhuja stands disposed of.
