### ORDER


**Subject: Appeal made by Shri Praveen Sakhujia under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhujia has filed an appeal, dated 18.02.2014 under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 27.11.2013.

Vide his application-dated 27.11.2013 bearing reference EIC-13-145; Shri Sakhujia had sought information regarding vacancies, abolition of posts etc. In reply, the CPIO vide letter dated 28.01.2014 had informed Shri Sakhujia that the information sought was not specific. The present appeal has been filed by Shri Sakhujia as he considers that the CPIO has deliberately not furnished the information to him.

I have gone through the appeal and observe that the information sought spans a period of 13 years. Under the circumstance, Shri Kannan Kasturi NS, DD (NT) & CPIO, EIC is hereby directed to allow inspection of relevant records to Shri Sakhujia, if he so desires, within 15 days of receipt of this order.

With the above directions, the appeal filed by Shri Sakhujia stands disposed of.
