ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 26 May 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 17 April 2014 (EIC-14-028).

Vide his RTI request dated 17 April 2014 Shri Praveen Sakhuja had sought information on the letter submitted by Shri Shekahnand regarding a compliant case in Tilak Marg Police Station New Delhi. The information sought reads as:

- date and time of receipt of copies of the referred letter in EIC for Director and CVO, 1 kindly provide certified copy of the document which can establish receipt of the letters in EIC is through EIA Delhi or directly in EIC
- Certified copy of action taken in the matter 2

RTI cell transferred the RTI request to two deemed CPIOs and one of the CPIO EIC vide his letter dated 5 May 2014 replied to Shri Sakhuja providing information at point no 1 and offered that the applicant is at a liberty to take the copy of the letter which was received by Director cell on 26 Dec 2013 after making a payment of Rs 2/- since information ran into one page. Further the application was transferred to Shri Somvir Sharma, in the Directors office for providing information under Section 6(3) of RTI act 2005

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 26 May 2014. The applicant also states that the other deemed CPIO Shri Somvir Sharma has not replied to the request of CPIO EIC and therefore the applicant is being denied of information and he be provided information free of cost.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, that the CPIO has stated that there has been one letter as sought by the applicant received in the Director cell which is on 26 Dec 2013. The applicant requires to know under RTI Act that what action has been taken on the letter and also the fact that how this letter has been received whether directly or through EIA Delhi

Orders:

In view of the offer to the document by CPIO EIC RTI cell may take up the matter with Director cell in getting the copy if desired by the applicant after payment of due charges as per RTI Act 2005 and also any action taken on the matter

This disposes off the appeal of Shri Praveen Sakhuja.
