#### ORDER

**Subject: Appeal made by Md Zia ul Haque under Section 19(1) of the Right to Information Act 2005**

#### **Facts of the Case:**

Md Zia ul Haque vide his email dated 22 May 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 5 May 2014.

Vide his RTI request dated 5 May 2014 Md Zia ul Haque had sought information on the details of service period at EIA Kochi.

Vide his RTI request dated 5 May 2014 Md Zia ul Haque had sought information on the details of the service period for service at EIA Kochi. The information sought reads as:

- The period of my posting at EIA Kochi as assistant Director
- Number of days spent by me on leave during my posting at EIA Kochi
- Total amount paid to me as salary and other dues for the said period
- Whether any overpayment was made to me during my posting at EIA Kochi. If so, why and how? Please mention the total amount of overpayment, if made and how and when it was recovered
- Whether there was any break of service (period). If so please mention the length or period

CPIO EIA Kochi vide his letter dated 19 May 2014 informed Md Zia ul Haque of the information giving a point-wise reply on the RTI application except for the last point which pertain to break in service. The reply could not be given as the service book was not with EIA Kochi. This position was explained to the applicant in letter of CPIO EIA Kochi

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 22 May 2014 and stated that the CPIO has not provided the information and hence he be directed to provide the same to applicant

Having gone through the appeal and replies given by the CPIOs, I am of the view that the applicant had been provided with the available information and as such there is no denial or concealment of the information on part of CPIO

**Orders:**

Since there is no concealment on part of CPIO EIA Kochi there is no infirmity in the reply and hence the appeal is disposed off.
