ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 26 May 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 5 April 2014 (EIC-14-023).

Vide his RTI request dated 5 April 2014 Shri Praveen Sakhuja had sought information on the public notice issued by EIA Delhi. The information sought reads as:

a Certified copy of the sanction note for an amount of Rs 53538/- duly approved by appropriate competent authority for release of public notice intimating that applicant has been removed from services, which appeared in news paper on 26 Sept 2013, as informed under RTI. If the amount conveyed under RTI is not correct then kindly take the actual amount sanctioned and provide the documents.

B certified copy of the all documents related with the release and printing ie

i. certified copy of the document initiated by the concerned department seeking permission for release of the public notice along with the matter to be printed

ii certified copy of the sanction for release and print of the notice

iii details of the newspaper/news agency to that the material was handed over for print

iv list detailing documents provided to the newspaper/news agency specifying date

v amount paid to the newspaper/news agency for the print in the news paper, supported with receipt issued by the newspaper / news agency on receipt of the payment.

RTI cell EIC vide his letter dated 11 April 2014 forwarded the application to CPIO EIA Delhi and two CPIOs at EIC for providing information to the applicant. CPIOs of EIC vide his letter dated 11 April 2014 and 16 April 2014 informed the applicant that since the matter is not handled by the section and hence no inputs cannot be processed.

CPIO EIA Delhi on 30 April informed the applicant of information there was no information available on records stated that no inputs could be given.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 26 May 2014.

The issues raised in the appeal of the applicant are that the information provided is not provided and hence the CPIOs be instructed to provide the information as requested by applicant.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that the applicant be provided with the information which exists as per defined under provisions of Section 2 of RTI Act 2005.

Orders:

There is no concealment of the information by the CPIOs and as such find no infirmity in the actions of CPIOs and as such no directions are being issued.

This disposes off the appeal of Shri Praveen Sakhuja.
