### **ORDER**

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

#### Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 26 May 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 2 May 2014 (EIC-14-037).

Vide his RTI request dated 2 May 2014 Shri Praveen Sakhuja had sought information on the records advices regarding the revival of 158 posts at EIAs. The information sought reads as:

As per information contained in 107 meeting agenda, revival of 158 posts was taken up with DOC. Applicant requires knowing the details of posts lapsed with present status of the same.

Kindly confirm number of posts revived with date of their revival, providing file noting held in the process

CPIO EIC vide his letter dated 6 May 2014 replied to Shri Sakhuja stating that the information as sought in the format does not exist. However in the interest of RTI a copy of the posts lapsed was provided .

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 26 May 2014.

The issues raised in the appeal of the applicant are that the information has not been provided to the applicant and therefore the CPIOs be directed to provide for the information immediately.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that the information sought pertains to the files/ records and advices on the matter of lapsed posts, revival and records thereof.

### Orders:

In the case instant I find that the CPIO EIC Delhi has provided the details of posts lapsed and as such there is no posts which have been revived so far so the CPIO has provided a Nil information.

I find no infirmity in the reply of CPIO relating to concealment of information and therefore dispose the appeal without any directions to CPIO EIC This disposes off the appeal of Shri Praveen Sakhuia.
