ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 26 May 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 19 April 2014 (EIC-14-027).

Vide his RTI request dated 19 April 2014 Shri Praveen Sakhuja had sought information on the complaint case in Tilak marg Police Station New Delhi. The information sought reads as:

- 1 Date and time of receipt of the referred letter in EIA Delhi kindly provide certified copy of the document which can establish receipt of the letter in EIA Delhi
- 2 Date and Time of receipt of the copy of the letter to be provided by EIA Delhi to EIC as required under conduct rules, kindly provide certified copy of document to prove receipt in EIA Delhi and simultaneously certified copy of the document confirming the letter was sent to EIC
- 3 Certified copy of the action taken report in the matter

CPIO EIA Delhi vide his letter dated 15 May 2014 replied to Shri Sakhuja providing information at point no 1 and since there was no information in respect of point no 2 and 3 no information was provided to the applicant

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 26 May 2014. The applicant states that the CPIO has denied information and as sought he had not provided the copy of the letter as mentioned in point 1 of the RTI request.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that there is no denial of information on part of CPIO EIA Delhi.

Orders:

CPIO EIA Delhi is directed to provide the copy of the letter as sought by the applicant from the records after the applicant has deposited required sum as per RTI Act 2005

This disposes off the appeal of Shri Praveen Sakhuja.
