ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 2 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 16 May 2014 2014 (EIC-14-041).

Vide his RTI request dated 16 May 2014 Shri Praveen Sakhuja had sought information on the issue of notesheet initiated by Shri Siwach on 6 Jan 2014 . The information sought reads as:

A Applicant provided with certified copies of the documents requested through RTI application no EIC 14-016 against a fees. Further scrutiny of note sheet initiated by Parmod Siwach AD under banner of RTI Cell on 6 Jan 2014 reveals of that the matter has been brought to the notice of CIC and matter has been forwarded to administration division for examination and submission of report to Department of Commerce.

Applicant requests for copy of the entire file noting held/documents in the process and actions taken by department of Commerce

CPIOs of EIC vide his letter dated 26 May 2014 informed the applicant that the applicant has been provided with the file notings and correspondences as available on records vide his letter dated 5 May 2014. For the action taken part CPIO EIC had transferred the application to CPIO DOC. The other information since was not available was not provided to the applicant.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 2 June 2014.

The issues raised in the appeal of the applicant had not been provided with the information and CPIO has concealed the information and the applicant seeks directions that he be provided the information.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the view that the applicant has been provided with some information whose annexures are not attached in the file and as such it may not be possible for me acting as FAA to decide the appeal and therefore the decision is taken accordingly

Orders:

The CPIOs may revisit the RTI request and forward a considered speaking order to the applicant within three weeks.

This disposes off the appeal of Shri Praveen Sakhuja.
