ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 25 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 10 March 2014 (EIC-14-018).

Vide his RTI request dated 10 March 2014 Shri Praveen Sakhuja had sought information on the following points.

- a. Fresh certified copies of the file noting declaring designations of the responsible personnel's that initiated and finalized the process.
- Certified copy of the Approval of the Commerce Secretary for promoting Shri Rajiv Raizada for the post of Additional Director as mentioned in the noting provided.
- c. Certified copy of the minutes of DPC placed at F/A as per notings provided
- d. Certified copy of the existing RRs taken on records
- e. Certified copy of the seniority list taken on records
- f. Certified copy of the minimum grading required for the post
- g. Certified copy of the vigilance clearance granted to eligible candidates placed at Flag D as mentioned
- h. Certified copy of the pay scale and grade pay after implementation of each pay commission raising from Rs 4500/-- Rs 57700 to 3744/- Rs 67000/- GP 8700/-

RTI Cell vide their letter 12 March 2014 forwarded the RTI request to Shri Kannan Kasturi DD(NT) EIC and CPIO EIC Delhi for providing the information to the applicant directly. Shri Kannan Kasturi DD(NT) EIC and CPIO EIC Delhi vide his letter dated 9 April 2014 informed the applicant that the information sought had already been provided to the applicant and in case any further information is required the applicant inspect the records

Applicant vide his letter dated 1 May 2014 requested the CPIO to provide inspection of records with a notice of three days. Applicant again vide his letter dated 12 May 2014 requested for date and time of inspection from CPIO EIC Delhi.

Since there was no reply to the applicant by CPIO the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 25 June 2014.

The issues raised in the appeal of the applicant are that he had had not been provided with the inspection despite offered by the CPIO and thereby causing concealing the information.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop.

Having gone through the appeal and replies given by the CPIOs, I am of the view that once the CPIO has offered inspection of records there should not be any intent of concealment however despite reminders inspection has not been arranged.

Orders:

CPIO EIC is directed to provide inspection of the records within 15 days of the order as per his offer for inspection dated 9 April 2014

This disposes off the appeal of Shri Praveen Sakhuja.
