ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 25 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 10 March 2014 (EIC-14-020).

Vide his RTI request dated 10 March 2014 Shri Praveen Sakhuja had sought information on the following points.

- 1 Kindly provide the details of manpower engaged in EIC on contract during period 1 Jan 2011 to 28 Feb 2014 in EIC
- 2 Kindly provide status of each engaged detailing
 - a. Date of each engagement
 - b. Date of termination of contract
 - c. Amount paid each month to each engaged
 - d. Date of fresh engagement for same purpose and others as listed at 1 to 3 above

RTI Cell vide their letter 12 March 2014 forwarded the RTI request to two CPIOs for providing the information to the applicant. Shri Kannan Kasturi DD(NT) EIC and CPIO EIC Delhi vide his letter dated 13 March 2014 informed the applicant that the information sought was not clear and the records can be verified through inspection with a notice of seven days. The other CPIO however provided the details of outsourced employees. The applicant vide his letter dated 5 May 2014 requested that he be informed about as offered by CPIO in his letter dated 13 March 2014 inspection of records with a notice of three days

Since there was no reply the applicant raised an appeal under-section 19(1) of RTI Act 2005 vide his letter dated 25 June 2014.

The issues raised in the appeal of the applicant are that he had had not been provided with the inspection despite offered by the CPIO and thereby causing concealing the information.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop.

Having gone through the appeal and replies given by the CPIOs, I am of the view that the RTI request of the applicant has been addressed by offering inspection however the inspection has not been provided.

Orders:

CPIO EIC is directed to provide inspection of the records within 15 days of the order as per his offer for inspection dated 13 March 2014

This disposes off the appeal of Shri Praveen Sakhuja.
