ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 11 July 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 16 May 2014 (EIC-14-042).

Vide his RTI request dated 16 May 2014 Shri Praveen Sakhuja had sought information on the details on the RTI application filed by Shri Kamal Kant Agarwal. The information sought details as under:

- I RTI application filed by Shri Kamal Kant Aggarwal
- II Reply of CPIO EIC
- III Report submitted by Dr S K Saxena Director EIC to CIC
- IV Action Taken in the matter by EIC and CIC

CPIO EIC vide his letter dated 26 May 2014 replied to Shri Sakhuja stating that the matter could not be disclosed to him under section 11 and section 8(1) (j) of RTI Act 2005 and therefore no information could be given

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 11 July 2014.

The issues raised in the appeal of the applicant are that the information provided is not provided and the same has been concealed intentionally by CPIO and therefore the information should be provided to applicant free of cost as the information is in public domain since it being an RTI application.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop.

I have gone through the appeal and the reply given by CPIO and after considered view I find that the RTI application filed by a third person and information provided thereto is held by the department and is as such qualified as third party information

Orders:

I find no reason to give no further directions to CPIO as there is no denial of the information to the applicant.

This disposes off the appeal of Shri Praveen Sakhuja.
