#### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 11 July 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 19 May 2014 (EIC-14-046).

Vide his RTI request dated 19 May 2014 Shri Praveen Sakhuja had sought information on the details where he had sought information on the process of initiating public notice wherein some sanction of Rs 53538 /- was also obtained from Competent Authority.

CPIO EIC vide his letter dated 26 May 2014 replied to Shri Sakhuja stating that as per records maintained at EIC there was no information on the matter and he also transferred the application to the CPIO EIA Delhi to provide information if any existed at EIA Delhi since the notice taken out pertained to an employee of EIA Delhi. CPIO EIA Delhi also vide his letter dated 16 June 2014 stated that there was no information on records with him and therefore no information could be given.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 11 July 2014.

The issues raised in the appeal of the applicant are that the information provided is not provided and the same has been concealed intentionally by CPIO and therefore the information should be provided to applicant free of cost.

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that the applicant can be provided with the information which exists in the domain of public authority and both CPIOs at EIC Delhi and EIA Delhi have stated that there being no information on records they are unable to provide any inputs.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop.

**Orders:**

I find no reason to give no further directions to CPIO as there is no denial of the information to the applicant.

This disposes off the appeal of Shri Praveen Sakhuja.
