### ORDER

**Subject: Appeal made by Smt. Sudesh Sharma under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Smt. Sudesh Sharma vide her letter dated 23 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to her RTI application request dated 23<sup>rd</sup> May 2014.

Vide her RTI request dated 23<sup>rd</sup> May 2014, Smt. Sudesh Sharma had sought information regarding her case of family pension in lieu of CPF and related notes and correspondence.

CPIO, EIC vide his letter dated 4<sup>th</sup> July, 2014 provided the information requested at Sl. No. 1, 4 & 5 on receipt of fee and the information sought at Sl. No. 2&3 was denied as per section 11 of RTI Act 2005 vide letter dated 10<sup>th</sup> June, 2014. The applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide her letter dated 27 July 2014 and reminders dated 07 September 2014 and 23 September 2014.

The issues raised in the appeal of the applicant are that the information has not been provided to the applicant and therefore the CPIOs be directed to provide the information.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Therefore the matter is being decided in this backdrop.

#### **Orders:**

In this case, I find that CPIO, EIC, Delhi has provided the copies of notes and correspondence made with Deptt. Of Commerce with regard to her case of family pension in lieu of CPF.

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any directions to CPIO, EIC.
