ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 12 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 02 August 2014.

Vide his RTI application dated 02 August 2014, Shri Praveen Sakhuja had sought information regarding retirement of EIC and EIA employees on 31 July 2014.

CPIO, EIA- Delhi vide his letter dated 5th September 2014 denied the information sought under section 11 of RTI Act 2005.

CPIO, EIC vide his letter dated 5th September 2014 informed the applicant about the information pertaining to EIC employee.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 12 September 2014.


The issue raised in the appeal of the applicant is that this information cannot be denied under Section 11 of Right to Information Act 2005.

Having gone through the appeal and reply submitted by CPIOs, I am of the view that CPIO, EIC has provided the information related to EIC employee. CPIO, EIA – Delhi has denied the information under section 11 of RTI Act 2005 stating that it pertains to third party.

Orders:

The CPIO, EIA- Delhi is directed to revisit the application dated 02 August, 2014 of the applicant and provide the information within 15 days of receipt of this order.

This disposes off the appeal of Shri Praveen Sakhuja.
