ORDER

Subject: Appeal made by Shri Sabyasachi Banerjee under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Sabyasachi Banerjee vide his letter dated 05 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIOs to his RTI application request dated 12th May 2014.

Vide his RTI request dated 12 May 2014, Shri Sabyasachi Banerjee had sought information regarding trust deed for disbursement of pension through LIC.

CPIO, EIC vide his letter dated 06 August, 2014 provided the information to the applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 05 September 2014.

The issue raised in the appeal of the applicant is that the agreement copy between the EIC and LIC is not provided.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.


Therefore the matter is being decided in this backdrop.
