ORDER

Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Parveen Kumar vide his letter dated 02 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application dated 22 July 2014.

Vide his RTI application dated 22 July 2014, Shri Parveen Kumar had sought information regarding his GPF withdrawal.

CPIO EI-Section, DoC vide her letter dated 14 August 2014 provided the related portion of note-sheet and correspondence of the requested information.

CPIO, EIC also provided the information to applicant vide his letter dated 25 August 2014.

Aggrieved by the reply of CPIO the applicant raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 02 September 2014.

The issue raised in the appeal of the applicant is that the authorities are intentionally concealing the information.


CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append. Therefore the matter is being decided in this backdrop.

Having gone through the appeal and the information provided by the CPIO, I am of the view that the request of applicant has been addressed by providing the information. There is no denial or concealment of information in this regard by CPIOs.

Orders:

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Parveen Kumar.
