**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 22 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 25 July 2014.

Vide his RTI application dated 25 July 2014, Shri Praveen Sakhuja had sought information regarding joining of Dr. Amit Sharma in EIA-Mumbai HQ and his relieving.

CPIO, EIA - Mumbai vide his letter dated 26 August 2014 informed the applicant about the information.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 22 September 2014.


The issue raised in the appeal of the applicant is that there was a typographical error by applicant while printing the name at serial no. 5 and also requested for detailed version of NIAW.

### **Orders:**

It is observed that attempt has been made on the part of CPIO, EIA- Mumbai to provide all the relevant documents requested by applicant in his RTI application. Seeking specific information later on based on receipt of documents in reference to a particular RTI can not be considered part of same RTI application. Therefore, either the applicant should be specific while seeking information or he should file separate/ fresh RTI for seeking further information. However, in the spirit of RTI, the instant appeal is disposed off with the direction to CPIO, EIA- Mumbai to provide the information requested at S. No. 5 of the RTI application dated 25.07.2014 as well as the detailed version of NIAW to the applicant free of cost within 15 days of this order. This should not be treated as precedence to seek further additional information under same RTI application ambit in future.
