### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 22 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 02 September 2014.

Vide his RTI application dated 02 September 2014, Shri Praveen Sakhuja had sought information regarding funds under planned funds/ central funds provided to EIAs.

CPIO, EIC vide his letter dated 16 September 2014 informed the applicant about the information.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 22 September 2014.


The issue raised in the appeal of the applicant is that the authorities are intentionally blocking the information.
