ORDER

Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Parveen Kumar vide his letter dated 02 October 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIO to his RTI application request dated 11 August 2014.

Vide his RTI request dated 11 August 2014, Shri Parveen Kumar had sought information regarding order passed by the Chairman, EIC on the applicant's representation dt. 23 July 2014 & follow-up action taken by EIC which include counter-representation to Chairman, steps taken to implement the same and to inform the applicant regarding order of Chairman, EIC.

CPIO EIC Vide his letter dated 25 August 2014 provided the information to the applicant.

Aggrieved by the reply of CPIO the applicant raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 02 October 2014.

The issue raised in the appeal of the applicant is that the information in respect of para "B" & "C" of the RTI application is incomplete and therefore the CPIOs be directed to provide the information

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Therefore the matter is being decided in this backdrop.

Orders:

In this case, I find no infirmity in the reply of CPIO and dispose the appeal without any further directions to CPIO EIC.

This disposes off the appeal of Shri Parveen Kumar.
