**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 17 November 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 10 November 2014.

Vide his RTI application dated 10 November 2014; Shri Praveen Sakhuja had sought information regarding deduction of Rs 764.00.

CPIO, EIC vide his letter dated 13 November 2014 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 17 November 2014.

The issue raised in the appeal is that the relevant and related information be provided to the applicant.

CPIO, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Having gone through the appeal and the information provided by the CPIO, EIC, I am of the view that there is no denial or concealment of information in this regard by CPIO and the request of applicant has been addressed by providing the information.

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.


This disposes off the appeal of Shri Praveen Sakhuja.
