ORDER

Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 8 December 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 10 November 2014.

Vide his RTI application dated 10 November 2014; Shri Praveen Sakhuja had sought information regarding issuance of Public Notice in newspapers about removal of applicant from the service.

CPIO, EIC & CPIO, EIA - Delhi vide letter dated 3rd & 16th December 2014 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 8 December 2014.


The applicant, in his appeal, has requested to provide the details of the requested files/ records and documents.
