ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 8 December 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 7 November 2014.

Vide his RTI application dated 7 November 2014; Shri Praveen Sakhuja had sought information regarding Tour of Director, EIC to Agra, Jaipur & Moradabad in Oct 2013, Feb 2013 and Mar 2013.

CPIO, EIC vide his letter dated 27 November 2014 provided the information to applicant.


The applicant, in his appeal, has requested to provide the information as requested.
