Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 9 January 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 7 November 2014.

Vide his RTI application dated 7 November 2014; Shri Praveen Sakhuja had sought information regarding special casual leave against EIC and EIA employees.

CPIO, EIA-Delhi vide his letter dated 4 December provided the information to applicant. CPIO, EIA – Delhi has also informed the applicant that similar RTI applications have been filed by applicant in the past to obtain the similar information, which is already provided.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 9 January 2015.

The applicant, in his appeal, has requested to provide the detail information as requested.

CPIO, EIA-Delhi have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Orders

I find no infirmity in the reply of CPIO, EIA and therefore dispose the appeal without any further directions to CPIO, EIA.

This disposes off the appeal of Shri Praveen Sakhuja.
