ORDER

Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 9 January 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 5 November 2014.


The applicant, in his appeal, has requested to provide the detail information as requested.
