ORDER

Subject: Appeal made by Smt. Rama under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Smt. Rama vide her letter dated 7 November 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to her RTI application request dated 30 August 2014.

Vide her RTI application dated 30 August 2014, Smt. Rama had sought information of three Ex- officials of EIA – Kochi as available in their service book.

CPIO, EIA- Kochi vide his letter dated 26 September 2014 has denied the information under Section 8(1) (j) of the RTI Act citing the CIC order dated 02.04.2014 which states that disclosure of personal information which has no relation to any public activity or public interest and that the disclosure of such information would cause unwarranted invasion of privacy of an individual.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 7 November 2014.

The applicant, in his appeal, has requested to provide the information available in the service book of three Ex-officials of EIA – Kochi regarding their eligibility for pension and option filed by them to continue to remain under CPF.


CPIO, EIA- Kochi has informed that information available in one's service book is essentially personal in nature and the same is exempted under Clause 8 (1) (j) of the RTI Act.

Having gone through the appeal and reply submitted by CPIO, EIA- Kochi, I am of the view that the disclosure of personal information available in the service book of a third person is exempted under Clause 8 (1) (j) of the RTI Act and it would cause avoidable invasion of privacy of an individual.

Orders:

I find no infirmity in the reply of CPIO, EIA- Kochi and therefore dispose the appeal without any further directions to CPIO.

This disposes off the appeal of Smt. Rama.
