**Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 9 January 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 28 November 2014.

Vide his RTI application dated 28 November 2014; Shri Praveen Sakhuja had sought information regarding amounts deposited by Director, EIC for the period 15.12.2013 to 31.03.2014.

CPIO, EIC vide his letter 3 December 2014 provided the information to applicant.

The applicant, in his appeal, has requested to provide specific information as requested.


CPIO, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.
